The regular meeting of the City Council was held in the Council Chamber, City Hall, at 4 P. M., Wednesday, February 7, 1940, with Mayor Pro Tem Hovis presiding in the absence of Mayor Douglas, with Councilmen Baxter, Britt, Hudson, Huntley, Little, Nance, Sides and Ward being present.

Absent: Mayor Douglas, Councilmen Albea and Wilkinson.

MINUTES APPROVED.

On motion of Councilman Huntley, seconded by Councilman Ward, the minutes of the January 31st. meeting were approved as read.

APPROVAL OF APPOINTMENT OF MRS. MARIAN B. MUNN, CASE WORKER IN JUVENILE DETENTION AND DOMESTIC RELATIONS COURT.

Judge Marion Redd, of the Juvenile Detention and Domestic Relations Court, informed the Council that the Board of Commissioners of Mecklenburg County had approved the employment of Mrs. Marian B. Munn as Case Worker in his Court, to fill the place made vacant by the resignation of Mrs. Frances Gregerson, at the same salary as paid to Mrs. Gregerson, and asked the approval of the City Council on this appointment.

Thereupon, Councilman Little, seconded by Councilman Ward, made a motion that this appointment be approved. Motion unanimously carried.

STREET NAME CHANGED- WILMORE DRIVE EAST TO WOODCREST AVENUE.

The City Manager reported receipt of a petition signed by a number of citizens in the vicinity of Wilmore Drive East asking that the block between York Road and Cliffwood Place now known as Wilmore Drive East, be changed to Woodcrest Avenue, due to considerable confusion resulting from the present name.

On motion of Councilman Sides, duly seconded by Councilman Little this change was authorized, with Councilman Britt voting "No".

SEWER EXTENSION - CLEVELAND AVENUE.

On motion of Councilman Little, seconded by Councilman Britt and carried, authority was given for the extension of a sewer on Cleveland Avenue, between Bland Street and Rensselear Avenue, a distance of 175 feet, to serve one house started and eight others proposed, at an estimated cost of \$192.50 for this extension.

SEWER EXTENSION - CHATHAM AVENUE.

On motion of Councilman Huntley, seconded by Councilman Little, the request of Mr. V. J. Guthery for extension of a sewer on Chatham Avenue, from the present sewer 275 feet south, to serve two houses, was authorized, at an estimated cost of \$286.00.

COST OF SNOW REMOVAL CHARGED TO EMERGENCY FUND.

The extra cost involved in removing the recent snow from the City streets was \$1,194.63, and on motion of Councilman Huntley, seconded by Councilman Britt and unanimously carried, this amount was authorized to be charged to the Emergency Fund.

COMMITTEES ON SALE OF PROPERTY AND TREES UNABLE TO REPORT DUE TO BAD WEATHER CONDITIONS.

Mr. Marshall reported that he had not contacted the special committees appointed to look into the matter of the sale of property near the Sugar Creek Disposal Plant, or the trees on the sidewalk on North Church Street, due to the bad weather conditions.
