RIGHT OF WAY FOR LAYING WATER MAIN IN WILKINSON BOULEVARD BETWEEN CITY OF CHARLOTTE AND I. M. COOK AND WIFE.

On motion of Councilman Wilkinson, seconded by Councilman Britt and unanimously carried, the Mayor and Clerk were authorized to sign a contract with I. M. Cook and wife, for right of way to lay an 8" water main in Wilkinson Boulevard to accommodate the plant of the General Land Improvement Company along the property owned by Mr. Cook and wife.

STREET NAME CHANGED - FAIRVIEW AVENUE TO SUNNYSIDE AVENUE.

On motion of Councilman Huntley, seconded by Councilman Nance and unanimously carried, Fairview Avenue is to be changed to Sunnyside Avenue; Fairview Avenue being a short street and the logical extension of Sunnyside Avenue. This was on petition from a number of citizens residing on this street.

SANITARY SEWER INSTALLATION IN HAWKINS STREET.

Request having been received from J. W. McClung, Jr. that an 8" sanitary sewer be installed in Hawkins Street, from West Boulevard towards West Kingston Avenue, a distance of 235-feet, to serve one house now started and estimated to cost \$199.10, on motion of Councilman Huntley, seconded by Councilman Britt, this installation was authorized.

AUTHORITY GIVEN TO PURCHASE ONE CAR EMULSION ASPHALT IF NECESSARY.

Mr. Armstrong requested permission to purchase one car of Emulsion Asphalt for allaying dust in City streets in the event that the Duke Power Company is unable to supply a sufficient amount of gas-oil for this purpose. The cost of this car of asphalt will be approximately \$650.00.

On motion of Councilman Wilkinson, seconded by Councilman Huntley, authority to purchase this material if necessary was given.

TRANSFER OF FUNDS FROM EMERGENCY FUND TO GENERAL FUND TO TAKE CARE OF SALARY INCREASES AUTHORIZED.

On motion of Councilman Hovis, seconded by Councilman Little, authority was given for the transfer of \$540.00 from the Emergency Fund to the General Fund, to take care of salary increases authorized after the budget was adopted.
