Pursuant to call, the City Council and the Board of County Commissioners met in joint session in the Council Chamber, City Hall, at 3 o'clock P. M., Wednesday, November 26, 1941.

Present for the City: Councilmen Albea, Beasley, Daughtry, Hovis, Little, Painter, Price, Ross and Ward, and City Manager R. W. Flack.

For the County: Chairman McAden, Commissioners Cashion, Hamilton, McDonald and Price, and County Attorney DeLaney.

Mr. Albea, as Mayor Pro Tem, called the meeting to order.

Mr. McAden, Chairman of the County Commissioners, introduced Mr. Wade Cashion, Director of State Institutions, and requested him to explain the possibility of the Federal Government taking over the Mecklenburg Industrial Home, which is jointly operated by the City and County Commissioners. Mr. Cashion explained in detail the plan which has been put into operation at Newbern, N. C.

After full discussion, Councilman Ross moved that this matter be taken up with the proper officials to see if the Federal Government will take this institution over and operate it without expense to the City and County. Also, that Mr. McAden, Chairman of the County Commissioners, be requested to take the matter up with the proper government officials- he to act for both the City and County. Motion seconded by Councilman Beasley and carried.

At Mr. McDonald's request, Mr. Cashion suggested that Mr. McAden first take the matter up with Mrs. Bost, Commissioner of State Board of Charities and Public Welfare, Raleigh, N. C., and request her to find out if the Federal Government would be interested in taking over the Mecklenburg Industrial Home and operate it in a manner similar to that used in the institution recently established by the Federal Government at Newbern, N. C.

#### PURPOSE OF MEETING.

At this point, Mayor Pro Tem Albea turned the Chair over to Mr. McAden, to complete the business of the joint meeting. Mr. McAden stated that this meeting had been called for the purpose of electing a Tax Supervisor for the two years beginning the first Monday in December, 1941. He read a letter of application from Mr. J. Arthur Henderson, the present Supervisor, asking that he be reappointed at the same salary.

Councilman Albea moved that Mr. J. Arthur Henderson, the present Tax Supervisor, be nominated to succeed himself, at the same salary. This was seconded by Councilman Ross. There being no other nominations or applications, the question was put and Mr. Henderson was unanimously elected to succeed himself at the same salary.

ELECTION OF ASSISTANT JUDGE OF DOMESTIC RELATIONS COURT.

Commissioner McDonald suggested that an assistant to the Judge of the Juvenile Detention and Domestic Relations Court, be elected to serve at the same salary during Judge Redd's absence, either from vacation or illness. Mr. McDonald moved that Mr. Charles W. Bundy be elected to fill this position. Motion seconded by Councilman Ward and unanimously carried.

MEETING OF COMMITTEE ON DELINQUENT TAXES ARRANGED.

Councilman Ross asked that a meeting be arranged between the members of the committee appointed to study the question of collecting delinquent taxes, and by agreement, a meeting was arranged to be held in the Commission room, Court House, at 3 o'clock P.M., Monday, December 1st.

ADJOURNMENT.

There being no further business Councilman Albea moved adjournment. Motion seconded by Councilman Painter and carried.
