Section 1. That the sum of \$340,000 is hereby estimated to be available from the State of North Carolina to Bluestar Silicones.



Section 5. This ordinance shall be effective upon adoption.



General Capital Investment Fund (2010) Center 47490	\$ 75,000


Section 2. That the sum of \$1,270,000 is hereby appropriated in the General Capital Investment Fund (2010) North Church Street Project (37203)



AN ORDINANCE TO AMEND ORDINANCE NUMBER 4450-X , THE 2010-2011 BUDGET ORDINANCE, APPROPRIATING \$16,804,107 IN FAA GRANT FUNDS FOR NEW RUNWAY PROJECTS AND TRANSFERRING \$9,408,473 OF 2007 SERIES B AND \$7,395,634 OF 2010 SERIES C GENERAL AIRPORT REVENUE BONDS TO THE DEBT SERVICE FUND.

BE IT ORDAINED, by the City Council of the City of Charlotte;

Section 1. That the sum of \$16,804,107 is available from an FAA grant for projects related to the new runway.

Section 2. That the sum of \$16,804,107 is hereby appropriated to the Airport Capital Budget:
2090 - 540.14 = \$9,408,473
2091 - 554.12 = \$2,505,993
2091 - 554.13 = \$4,889,641

Section 3. That the sum of \$9,408,473 of 2007 Series B General Airport Revenue Bonds is transferred to the Debt Service Fund.


Section 4. That the sum of \$7,395,634 of 2010 SERIES C GENERAL Airport Revenue Bonds is transferred to the Debt Service Fund.
