Section 3. That the Finance Director is hereby authorized to advance the sum of \$900,000 to the projects designated in Section 2 from the following sources:





Section 1. That the sum of \$465,000 is hereby estimated to be available from the following sources of revenues:







AN ORDINANCE TO AMEND ORDINANCE NUMBER 1059-X, THE 1998-1999 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION FOR A US DEPARTMENT OF JUSTICE GRANT.

- Section 4. It is the intent of this ordinance to be effective upon its adoption.


