

ORDINANCE 531

AN ORDINANCE AMENDING CHAPTER 14, SECTION 131
OF THE CHARLOTTE CITY CODE

WHEREAS, on May 14, 1984, the Charlotte City Council approved a policy to provide for a 25 miles per hour speed limit on non-thoroughfare residential streets; and,

WHEREAS, it has been determined, upon the basis of an engineering and traffic investigation, that a lowered speed limit on certain streets of the City of Charlotte is not inappropriate; and,

WHEREAS, G.S. 20-141 (speed restrictions) requires adoption of a speed limit ordinance to amend Chapter 14, Section 131(c) of the Charlotte City Code,

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Charlotte,


SECTION 1: That Schedule X referred to in Chapter 14-131(c) of the Charlotte City Code be amended by declaring a speed limit on the following City System streets as described below:

Bevington Place from Rea Road to Coburn Court	25 MPH
Brewton Drive from Eureka Street to Oaklawn Avenue	25 MPH
Chilham Place from cul-de-sac west of Biddstone Court to cul-de-sac east of Ridgeloach Lane	25 MPH
Colony Woods Drive from Providence Road West to Coachman Circle	25 MPH
Double Oaks Road from Newland Road to Oaklawn Avenue	25 MPH
Genesis Park Place from Tinnin Avenue to dead end, 70 feet from Peaceful Way	25 MPH
Hampton Oaks Lane from Kuykendall Road to cul-de-sac	25 MPH
Mosstree Circle from Farmgate Drive to cul-de-sac	25 MPH

Netherhall Drive from Saxonbury Way to cul-de-sac	25 MPH
Ridgeloch Place from Pineville-Matthews Road to cul-de-sac	25 MPH
Rushwind Drive from Oaklawn Avenue to dead end, 200 feet from Peaceful Way	25 MPH

SECTION 2: Section 1 shall become effective upon adoption by Charlotte City Council and after signs are erected giving notice of the speed limits, as required by N.C.G.S. Section 20-141.


NOW THEREFORE BE IT ORDAINED by the City Council of the City of Charlotte,

SECTION 1: That Schedule X referred to in Chapter 14-131(c) of the Charlotte City Code be amended by declaring a speed limit on the following City System streets as described below:

- Brandon Forest Drive from Sharon Road West to Lytham Drive 25 MPH
- Marsh Road from Park Road to South Boulevard 30 MPH


NOW THEREFORE BE IT ORDAINED by the City Council of the City of Charlotte,

Chesapeake Drive from Hoskins Road to Auten Road 45 MPH

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;


Section 1. That the sum of \$221,000 is available in the Water and Sewer Operating Fund Balance (7101).
