Zulu Express, Inc. DBA Fast Mart	\$ 18,400


Section 2. That the sum of \$20,900 is hereby appropriated in the General Capital Investment Fund (2010) Developer Contributions Project (28152)






ORDINANCE

AN ORDINANCE ORDERING THE DEMOLITION AND REMOVAL OF THE BUILDING AT 3322 TUCKASEEGEE ROAD PURSUANT TO THE NON RESIDENTIAL BUILDING CODE OF THE CITY OF CHARLOTTE AND ARTICLE 19, PART 5, CHAPTER 160A OF THE GENERAL STATUTES OF NORTH CAROLINA, SAID BUILDING BEING THE PROPERTY OF ALMA D. FRIDAY 1922 STONEYBROOK DRIVE CHARLOTTE, NC 28214

WHEREAS, the building located at 3322 Tuckaseegee Road in the City of Charlotte has been found by the Code Enforcement Official of the City of Charlotte to be in violation of the Non Residential Building Code of the City of Charlotte and the owners thereof have been ordered to demolish and remove said building; and

WHEREAS, said owner(s) have failed to comply in a timely fashion.




