ORDINANCE NO. 129-X

AN ORDINANCE TO AMEND ORDINANCE NO. 939-X, THE 1968-69 BUDGET ORDINANCE, AUTHORIZING THE TRANSFER OF A PORTION OF THE CAPITAL IMPROVEMENT BUDGET TO THE GENERAL FUND.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina:

SECTION 1. That the total sum of \$25,537 of the Capital Improvement Program Budget is hereby transferred to the 1968-69 Budget for the General Fund - Central Services - Account No. 505.210 from the following accounts: \$16,862 from Account Code No. 537.08; \$3,135 to be transferred at the present time and \$2,500 to be transferred at the end of March, 1969 from Account Code No. 537.44; and \$3,040 from Account Code No. 537.68, said amounts then to be used to make the necessary alterations to the space on the second floor of City Hall Annex most recently vacated by the Planning Commission, so that the Engineering Department on Third Floor of City Hall may be moved there, and to provide central air conditioning to all three floors of the Annex.

ORDINANCE NO. 130-X
