

ORDINANCE NO. 651

AN ORDINANCE AMENDING CHAPTER 2 OF THE CITY CODE RELATIVE TO PARKING ON CITY STREETS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 2, Article VI of the City Code of the City of Charlotte (O. B. 10), as amended, be, and the same is hereby further amended as follows:

§ SCHEDULE NO. 1 entitled, "PARKING PROHIBITED AT ALL TIMES", by adding the following streets:

Alexander Street	10th. Street to 11th St. west side
Baxter Street	Kings Dr. to Independence Blvd, both sides
Berkley Avenue	Morehead St. to Harding Pl. West side
Brunswick Ave.	Kings Dr. to Edgehill Rd. both sides
Cherry Street	4th. Street to Independence Blvd. west side.
Dartmouth Pl.	Queens Rd. to Providence Rd. south side
Dowd Rd.	Cliffwood to Railroad both sides
Edgehill Rd.	Brunswick Ave. to Morehead St. both side
Freedom Dr.	Thrift Rd. to City Limits both sides
Independence Blvd.	Alexander St. to Baxter St. both sides
Independence Blvd.	Cecil St. to Elizabeth Ave. both sides
Independence Blvd.	Elizabeth Ave. to Fifth St. west side
Independence Blvd.	Fifth St. to Morningside Dr. both side
Independence Blvd.	Rockway to Waterman both sides
Independence Blvd.	Commonwealth to City Limits both sides
Kennon Street	Hawthorne La. to Pegram St. south side
Morehead St.	Queens Rd. to Kings Dr. both sides
Queens Rd.	Morehead to 250 ft. north on west side
Seventh St.	Brevard St. to Caldwell St. south side
Spring St.	Pharr to Johnson north side
10th Street	Church St. to Tryon St. south side

And further amend said Article VI, SCHEDULE NO. 1-A, entitled, "PARKING PROHIBITED - LIMITED TIME", by adding the following streets:

7:30 to 9:30 A.M. and 4:30 to 6:30 P.M.

<u>LOCATION</u>	<u>FROM</u>	<u>TO</u>	<u>SIDE OF STREET</u>
Seventh Street	Independence Blvd.	Caldwell St.	south

And further amend said Article VI Schedule No. 1-A, by striking out the following streets:

7:30 to 9:30 A.M. and 4:30 to 6:30 P.M.

<u>LOCATION</u>	<u>FROM</u>	<u>TO</u>	<u>SIDE OF STREET</u>
Independence Blvd.	Alexander St.	Baxter St.	both
Independence Blvd.	Cecil Street	Elizabeth Ave.	east
Seventh St.	Independence Blvd.	Brevard St.	south

Section 2. That, this Ordinance shall be in full force and effect from and after its adoption.
