ORDINANCE NO. 387-X

AN ORDINANCE AUTHORIZING THE TRANSFER OF FUNDS FROM THE UNENCUMBERED BALANCE OF SEVERAL CAPITAL IMPROVEMENT PROJECT ACCOUNTS AND AMENDING ORDINANCE 176-X, THE 1971-72 BUDGET ORDINANCE AUTHORIZING THE TRANSFER OF FUNDS TO PAY FOR THE CONSTRUCTION OF THE GREENVILLE NEIGHBORHOOD CENTER.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the following sums are transferred as indicated below:

These funds will be used for partial payment of construction costs on the Greenville Neighborhood Center.

Section 2. That the sum of \$45,300 is hereby transferred from Account 530.01 (Social Security and Retirement Account in the General Fund of the 1971-72 budget) into Account 553.02 (Greenville Neighborhood Center), these funds to be used to complete the construction of this project, subject to the condition that when the Federal government reimburses the City for its share of the cost that \$45,300 will be credited against Account 530.01 so that the original amount of the appropriation will be restored.

Section 3. That this ordinance shall become effective upon its adoption.

ORDINANCE NO. 388-XAN ORDINANCE ESTABLISHING A CAPITAL IMPROVEMENT PROJECT ACCOUNT FOR THE SHARON LANE - SHARON ROAD INTERSECTION IMPROVEMENTS.

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That the State Grant-In Aid Revenue Account in the Capital Project Fund is hereby raised \$50,000 and that Capital Improvement Project Account 537.77 (Sharon Lane - Sharon Road Intersection Improvements) is hereby established with an appropriation of \$50,000.

Section 2. That this project shall be carried out in accordance with the contractual provisions set forth in the Municipal Agreement approved by the City of Charlotte and the State Highway Commission on August, 1971, under which the state agreed to reimburse the City for the full cost of intersection improvement.
