Section 1. That the sum of \$428,595 is hereby estimated to be available from the following sources:




Section 2. That the sum of \$1,850,000 is hereby appropriated to the Aviation Operating Fund (7402) as follows:

BE IT ORDAINED, by the City Council of the City of Charlotte;


Section 1. That the sum of \$300,000 is hereby estimated to be available from the unrestricted balance of the Pay-As-You-Go Fund (2011).

Section 4. This ordinance shall be effective immediately.





AN ORDINANCE TO AMEND ORDINANCE NUMBER 1059 -X, THE 1999 - 2000 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION FOR THE 2010 CHARLOTTE CENTER CITY URBAN DESIGN PLAN.

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$465,395 is hereby estimated to be available from the General Fund Contingency Account (101-530.00).
- Section 2. That the sum of \$175,000 is hereby transferred from the General Fund Contingency Account and is appropriated to non-departmental General Fund -- Uptown Development (101-530.60).
- Section 3. All ordinances in conflict with this ordinance are hereby repealed.
