AN ORDINANCE AMENDING ORDINANCE NO. 255-X, SCHEDULE D OF SECTIONS 1 AND 2, TO AUTHORIZE AN APPROPRIATION FOR MODEL CITIES NEIGHBORHOOD CENTERS AND NEIGHBORHOOD AGENT PROGRAMS.
