

AN ORDINANCE AMENDING CHAPTER 15, ARTICLE I., "OFFENSES AND MISCELLANEOUS PROVISIONS," OF THE CITY CODE OF THE CITY OF CHARLOTTE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE, NORTH CAROLINA, THAT:


SECTION 1. Chapter 15, Section 15-1 shall be amended to read as follows:

"SEC. 15-1. Distribution of handbills, etc; requirements.

- (a) It shall be unlawful for any person to throw, deposit, place or distribute any handbills, advertisements, cards, circulars, leaflets, folders, banners, letters, magazines or pamphlets in or upon private property except by (i) handing the material to the occupant; or, (ii) by placing or depositing said material behind the outer door; or, (iii.) securely attaching said material to the door knob or handle; or (iv.) Placing said material on the porch or stoop, provided that it shall be wrapped, bound, or lockfolded in such a manner so as to prevent the material from being blown or scattered. The provisions of this subsection shall not apply to the distribution of the United States mail nor to newspapers.
- (b) It shall be unlawful for any person, firm, corporation, or organization to deposit in, paste on, or attach to any motor vehicle any handbills, advertisements, cards, circulars, leaflets, folders, banners, letters, or pamphlets or to cause said materials to be deposited in, pasted on or attached to any motor vehicle without the consent of the owner. Nothing contained in this subsection shall prohibit the attachment to a motor vehicle of a citation or public safety information issued or published by or on behalf of the City of Charlotte."

Section 2. This ordinance shall become effective January 11, 1999.


ORDINANCE NUMBER: 1177-X

AN ORDINANCE TO AMEND ORDINANCE NUMBER 1059-X, THE 1998-1999 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION FOR A U.S. DEPARTMENT OF JUSTICE GRANT.

BE IT ORDAINED, by the City Council of the City of Charlotte:

- Section 1 That the sum of \$152,160 is hereby estimated to be available from the U. S. Department of Justice to provide financing for a study on the effects of bullying and intimidation in 11 Charlotte schools.
- Section 2. That the sum of \$152,160 is hereby appropriated to the Police Department budget in the General Fund.
- Section 3. That the existence of this program may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the program and funds are to be carried forward to subsequent fiscal years until all funds are expended.
- Section 4. It is the intent of this ordinance to be effective upon its adoption.

AN ORDINANCE TO AMEND ORDINANCE NUMBER 1059-X, THE 1998-1999 BUDGET ORDINANCE, PROVIDING AN APPROPRIATION FOR THE TORRENCE CHAPEL ROAD WATER MAIN

BE IT ORDAINED, by the City Council of the City of Charlotte;

- Section 1. That the sum of \$80,000 is hereby estimated to be available from Water and Sewer Capital Project Bond Fund Fund Balance (2071.43710.4110)
- Section 2. That the sum of \$80,000 is hereby appropriated to Water and Sewer Capital Project Fund (2071) - Torrence Chapel Road Water Main (635.51)
- Section 3. That the existence of the project may extend beyond the end of the fiscal year. Therefore, this ordinance will remain in effect for the duration of the project and funds are to be carried forward to subsequent fiscal years until all funds are expended or the project is officially closed.
- Section 4. All ordinances in conflict with this ordinance are hereby repealed.
- Section 5. This ordinance shall be effective upon adoption.
