BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-12MF to O-15 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

BEGINNING at the intersection of the centerlines of N. C. Highway 49 and Mallard Creek Church Road; thence along said centerline of Mallard Creek Church Road S. 30-35 E. 140.20 feet; thence S. 40-35E, 135.21 feet; thence S. 45-11-30W. 209.12 feet; thence N. 41-00W. 286.98 feet to the centerline of N. C. Highway No. 49; thence along said centerline N. 49-00E. 235.00 feet to point of BEGINNING.

Section 2. That, this ordinance shall become effective upon its adoption.

BEGINNING at the southwesterly intersection of Beatties Ford  
Road and Fairdale Drive; thence along the westerly margin  
of said Beatties Ford Road S. 10-48E. 200.0 feet; thence  
S. 79-12W. 216.0 feet to the easterly margin of Fairbrook  
Drive; thence along said easterly margin of Fairbrook Drive  
N. 13-23-40W. 217.70 feet to the southerly margin of Fair-  
dale Drive; thence along said southerly margin of Fairdale  
Drive in an easterly direction 227.08 feet to the point of  
BEGINNING.
