An Ordinance Amending the City Code  
with respect to the Zoning Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the  
City of Charlotte is hereby amended by changing from R-6MF to B-1  
on the Official Zoning Map, City of Charlotte, N. C. and Perimeter  
Area the following described property:

BEGINNING at the intersection of the southwesterly margin of  
Clanton Road and the westerly margin of Interstate Highway 77,  
and running thence with said southwesterly margin of Clanton  
Road three calls as follows:

N. 60-04-30 W. 316.18 feet  
N. 26-03-00 E. 10.00 feet  
N. 63-57-00 W. 364.00 feet;  
thence S. 70-49-00 W. 89.93 feet; thence S. 47-57-50 E. 962.37 feet to  
the westerly margin of Interstate Highway 77; thence with said westerly  
margin two calls as follows:

N. 3-52-50 E. 269.72 feet  
N. 32-59-40 W. 100.59 feet to point of BEGINNING.

Section 2. That, this ordinance shall become effective upon its  
adoption.

An Ordinance Amending the City Code  
with respect to the Zoning Ordinance

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-9MF to B-2 on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

BEGINNING at a point in the centerline of Idlewild Road, said point being located 672.96 feet in a westerly direction from the intersection of the centerlines of Idlewild Road and Independence Boulevard; thence S. 34-24 E. 1953.30 feet to the centerline of State Road 1009; thence with said centerline in a southerly direction 181.03 feet; thence N. 34-24 W. 2,208.21 feet to the centerline of Idlewild Road; thence with said centerline in a northeasterly direction 212.51 feet to point of BEGINNING.

Section 2. That, this ordinance shall become effective upon its adoption.
