BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City
of Charlotte is hereby amended by changing from R-9MF to O-6
on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area
the following described property:

Beginning at a point in the intersection of the southerly
margin of Springway Drive and the westerly margin of East-
way Drive and running thence with said margin of Springway
Drive two courses as follows: (1) S. 70-00 W. 129.77 feet;
(2) N. 72-00 W. 36.5 feet; thence S. 19-15 W. 157.7 feet;
thence N. 70-07 E. 30 feet more or less to a point in the
centerline of an unnamed branch; thence with the centerline
of said branch two courses as follows: (1) S. 20-19-20 W.
10.86 feet; (2) S. 15-13-50 E. 16.52 feet; thence N. 70-07E.
241.19 feet to a point in the westerly margin of Eastway
Drive; thence with said margin of Eastway Drive N. 19-53 W.
125.0 feet to the point of beginning.
