

Ordinance No. 610-X

AN ORDINANCE TO AMEND ORDINANCE NO. 214-X, THE 1974-75 BUDGET ORDINANCE, ADDING A COMMUNITY DEVELOPMENT FUND AND ESTABLISHING REVENUE AND EXPENDITURE ACCOUNTS FOR THE IMPLEMENTATION OF THE COMMUNITY DEVELOPMENT PROGRAM

BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;

Section 1. That a Community Development Block Grant fund is hereby established as a part of the City of Charlotte, North Carolina finance and accounting system bearing fund number 6900.


Section 2. That the sum of \$40,000 is hereby established as a revenue in the Community Development Block Grant fund bearing revenue code number 5901. The source of these funds shall be an advance on a grant proposal submitted April 15, 1975.

Section 3. That the amount of \$40,000 is hereby established in Account No. 100.00 (Community Development-Administration) these funds to be used for salaries and operating expenses for community development employees hired between the adoption date of this ordinance and the date the full appropriation ordinance for community development block grant funds is approved by City Council.

Section 4. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall become effective upon its adoption.


BE IT ORDAINED by the City Council of the City of Charlotte, North Carolina;
