An Ordinance Amending Chapter 23
of the City Code - Zoning Ordinance

An Ordinance Amending the City Code
with respect to the Zoning Ordinance:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-9 to R-9MF on the Official Zoning Map, City of Charlotte, N. C. and Perimeter Area the following described property:

BEGINNING, at a point located on the southerly margin of Carriage Drive, said point being located at the northeasterly corner of Griffin Realty property as described in a deed recorded in Deed Book 3146, page 545 in the County Public Registry, and running thence S. 4-04-11 E. 0.30 feet; thence S. 73-58-11 E. 205.34 feet; thence S. 85-09-40 E. 121.65 feet; thence S. 85-09-46 E. 857.4 feet; thence N. 18-28-26 E. 72.15 feet; thence N. 85-49-45 W. 117.03 feet; thence S. 81-18-31 W. 193.88 feet; thence N. 72-36-30 W. 199.98 feet; thence N. 77-53-50 W. 150.63 feet; thence N. 72-29-57 W. 175.00 feet; thence S. 17-30-03 W. 59.31 feet; thence N. 63-25-19 W. 204.18 feet to the easterly margin of Carriage Drive and running thence with the said margin and with the arc of a circular curve to the right having a radius of 275.85 feet an arc distance of 206.45 feet to the point of BEGINNING.

Section 2. That, this ordinance shall become effective upon its adoption.

AN ORDINANCE TO AUTHORIZE THE TRANSFER OF FUNDS FROM VARIOUS CAPITAL IMPROVEMENT PROJECTS TO THE WEST 3RD STREET PROJECT.
