Section 1. That, Chapter 23, Section 23-8, of the Code of the City of Charlotte is hereby amended by changing from R-6MF and B-1 to R-6 on the Official Zoning Map, City of Charlotte, N.C. the following described property:

BEGINNING at a point located at the intersection of the centerline of Spring Street and Oaklawn Avenue; running thence in a westerly direction along the centerline of Oaklawn Avenue 1800 feet more or less to the intersection of the centerline of Burton Street; running thence in a southerly direction along the centerline of Burton Street 550 feet more or less to the intersection of the extension of the rear property line of Lot 1 in Block 6 as shown on a plat recorded in Map Book 17, Page 55 in the County Public Registry; running thence S.68-22-24E. 1091.0 feet; running thence along the extension of the easterly property line of Lot 16 in Block 6 as shown on a plat recorded in Map Book 17, Page 55 in the County Public Registry to the centerline of Fontana Avenue; running thence in an easterly direction along the centerline of Fontana Avenue 319.0 feet more or less to the intersection of the centerline of Spring Street; running thence in an easterly direction along the centerline of Spring Street 609.0 feet more or less to the point of BEGINNING.

BEGINNING at a point located along the westerly margin of Statesville Avenue, said point being at the intersection of the southerly margin of Street No. 3 as shown on the Redevelopment Plan for Greenville; running thence with the arc of a circular curve to the right having a radius of 3868.72 feet, an arc distance of 220.0 feet; running thence with the arc of a circular curve to the left having a radius of 20.0 feet, an arc distance of 29.96 feet; running thence with the arc of a circular curve to the right having a radius of 254.18 feet, an arc distance of 192.69 feet; running thence with the arc of a circular curve to the left having a radius of 20.0 feet, an arc distance of 30.29 feet; running thence S.57-24-53W. 178.43 feet; running thence with the arc of a circular curve to the left having a radius of 312.03 feet, an arc distance of 82.0 feet; running thence S.29-08-13E. 207.50 feet; running thence S.86-38-54E. 295.0 feet to the point of BEGINNING.





AN ORDINANCE TO AMEND ORDINANCE NUMBERS 237-X, 190-X, 363-X, 708-X, THE MODEL CITIES BUDGET ORDINANCES FOR THE YEARS 1970-73, TRANSFERRING FUNDS FROM THE UNAPPROPRIATED BALANCE OF THE MODEL CITIES FUND TO INCREASE APPROPRIATIONS FOR FOUR EXISTING ACTIVITIES AND TO APPROPRIATE FOR A SUPPLEMENTAL HUD MODEL CITIES GRANT.

BE IT ORDAINED by the City Council of the City of Charlotte,

Section 1. That the sum of \$183,911 is hereby transferred from the unappropriated balance of the Model Cities fund to the following accounts:

These funds will be used to provide a supplemental appropriation for the aforementioned projects for the period ending June 30, 1975. The unappropriated balance of the Model Cities fund is derived from the residual funds of the four action years contributed in the following manner: First Action Year, \$21,573; Second Action Year, \$62,034; Third Action Year, \$66,122; and Fourth Action Year, \$34,182; totaling \$183,911. The expenditures of foregoing appropriations will be chargeable to the unappropriated balance of the Model Cities fund in the sequence of their contribution. 


