

- Section 3. It is the intent of this ordinance to be effective upon its adoption.



AMENDING CHAPTER 6

ORDINANCE AMENDING CHAPTER 6 OF THE CHARLOTTE CITY CODE
ENTITLED "BUSINESS AND TRADE"

Section 1. Chapter 6 of the Charlotte City Code is amended by rewriting subsection (a) of Sec. 6-104 to read as follows:

"(a) Vendor locations shall be assigned by the city manager or his designee either on a first-come-first-served basis, by lottery, or in accordance with an otherwise fair procedure. A vendor shall be permitted to reapply and to retain a site location for as long as the vendor remains in good standing with the rules and regulations of the Tryon Street Mall Vending Program."


