HEARINGS ON PETITIONS FOR ZONING CHANGES.


WHEREAS, the City Council has received a petition for a zoning change, which petition, numbered 74-43 is on record in the Office of the City Clerk, and

A RESOLUTION AUTHORIZING CONDEMNATION PROCEEDINGS FOR THE ACQUISITION OF PROPERTY BELONGING TO JAMES R. BLAKELY AND WIFE, ANNIE L. BLAKELY; ROBERT T. HOYLE AND WIFE, ISABEL S. HOYLE; AND CHARLOTTE-MECKLENBURG BOARD OF EDUCATION, EASEMENT INTEREST, LOCATED AT 11401 OLD STATESVILLE ROAD (HWY 115) IN THE COUNTY OF MECKLENBURG FOR THE HUNTERSVILLE WATER TANK SITE.

WHEREAS, the City Council finds as a fact that it is necessary to acquire certain property belonging to James R. Blakely and wife, Annie L. Blakely; Robert T. Hoyle and wife, Isabel S. Hoyle; and Charlotte-Mecklenburg Board of Education, Easement Interest, located at 11401 Old Statesville Road (Hwy 115) in the County of Mecklenburg on which to construct an elevated water tank, a part of the water supply and distribution system; and

WHEREAS, the City has in good faith undertaken to negotiate for the purchase of this property, but has been unable to reach an agreement with the owners for the purchase price.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, that pursuant to Section 7.81, Chapter 713 of the 1965 Session Laws of North Carolina, being the Charter of the City of Charlotte, as amended, and the authority granted in Chapter 160A-241 of the General Statutes of North Carolina, condemnation proceedings are hereby authorized to be instituted against the property of James R. Blakely and wife, Annie L. Blakely; Robert T. Hoyle and wife, Isabel S. Hoyle; and Charlotte-Mecklenburg Board of Education, Easement Interest, located at 11401 Old Statesville Road (Hwy 115) in the County of Mecklenburg, under the procedures set forth in Article 9, Chapter 136 of the General Statutes of North Carolina, as amended; and

BE IT FURTHER RESOLVED that \$17,050.00, the amount of the appraised value of said property, is hereby authorized to be deposited in the office of the Clerk of Superior Court of Mecklenburg County, North Carolina, together with the filing of the Complaint and Declaration of Taking.
