Nevin-Gibbon Road Sidewalk Project

This project will include:

- Sidewalk along the north side of Nevin Road from Alpine Lane to Gibbon Road,
- Sidewalk along the south and west sides of Gibbon Road from Nevin Road to West Sugar Creek Road, and
- Sidewalk along east side of West Sugar Creek Road from Mallard Creek Road to Bisaner Street.

As we continue coordination efforts, the project team is hopeful that an agreement can be reached with Norfolk Southern Railroad to provide a pedestrian crossing over railroad tracks between Derita Avenue and West Sugar Creek Road.

Right-of-way acquisitions are complete and utility relocations are now underway. Utility companies estimate work will be complete in November and sidewalk construction will begin early 2017.
