


COMMUNITY MEETING REPORT

**CHANGES MADE TO THE PETITION AS A RESULT OF THE COMMUNITY MEETING AS OF THE DATE HEREOF:**


No changes were made to the Rezoning Petition or to the Petitioners' Conditional Rezoning Plan solely as a result of the Community Meeting.
