RE: Rezoning Petition # 2008-053 Whitehall Corporate Center (overland connector)

This is the third correspondence (2/20/08, 4/8/08) from Mecklenburg County Park and Recreation Department (MCPR) regarding rezoning petition #2008-053. We suggest that these comments be incorporated into the Planning Commission staff review notes and written into the Pre-Hearing Staff Analysis to the fullest extent possible. These steps should ensure MCPR's notes are conveyed to and incorporated by the petitioner during plan revision.

The petitioner's properties are located in the Southwest Park District on Arrowood Road just east of I-485. A Lynx light rail transit station exists at South Boulevard. The 1999 Mecklenburg County Greenway Master Plan identifies Steele Creek, Coffey Creek, Sugar Creek, Kings Branch and Little Sugar Creek as a future greenway corridors and a significant and lengthy overland connector for these greenways is planned for Arrowood Road/Starbrook Drive.

General comments

The petitioner has shown an 8' planting strip and a 6' wide sidewalk along Arrowood Road on Sheet L3 of 5 dated 5/16/08. MCPR appreciates that the petitioner is willing to provide an 8' wide planting strip along Arrowood Road. MCPR further requests that the

petitioner increase the width of the sidewalk to 8' from the 6' width shown. The overland connector is an important part of the Mecklenburg County Greenway System. MCPR has secured CDOT support for this request.
