AN ORDINANCE AMENDING APPENDIX A OF  
THE CITY CODE - ZONING ORDINANCE

ORDINANCE NO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. Appendix A, "Zoning" of the Code of the City of Charlotte is hereby amended as follows:

A. CHAPTER 2 DEFINITIONS AND RULES OF CONSTRUCTION

1. PART 2: DEFINITIONS

a. Amend Section 2.201, "Definitions", by adding the following definition in alphabetical order:

**Pet crematorium**

**A location or building containing properly installed, certified apparatus intended for use in the act of cremation of the remains of deceased household animals.**

B. CHAPTER 9 GENERAL DISTRICTS

1. PART 1: TABLE OF USES AND HIERARCHY OF DISTRICTS

a. Amend Table 9.101 so as to designate a pet crematorium as a use permitted by right in the I-1 and I-2 zoning districts by **adding the symbol "X" in the I-1 and I-2 zoning district columns set forth in the "Industrial Uses" section, under a new line item termed "pet crematorium"**.

2. PART 2: INDUSTRIAL DISTRICTS

a. Amend Section 9.1103, "Uses permitted by right" in I-1 and I-2 zoning districts by adding pet crematoriums as a use permitted by right. The addition shall be added in alphabetical order as subsection (58.1), with the existing subsections renumbered thereafter. The new text shall read as follows:

**(58.1) Pet crematoriums**

Section 2. This Ordinance shall become effective upon its adoption.
