
On November 19, 2008 at 6:00pm at Friendship Missionary Baptist Church in Conference Center C, we held a community meeting for the above-referenced rezoning petition. I have attached a listing of the individuals and organizations we notified by mailing a letter (which is also attached), as well as a roster of the individuals who attended the meeting.

At the meeting, attendees asked about:

- The number of residents that would inhabit the temporary women's shelter component of the proposed building renovation, and what staffing, security and supervision measures we would take in operating the shelter.
- What fencing and security measures we would take on the building site and around its perimeter. We discussed in detail the fencing and screening currently shown on the site plan; some residents wanted to be sure that the shrubbery used for screening wasn't so high that it would provide a hiding place for ambushes by criminals. We also assured them that while we are required by zoning regulations and planning department requirements to include the screening, we would make every effort to use shrubs that wouldn't create such a situation.
- What type of lighting we would put in place on and around the site; we agreed to work with community members and the City of Charlotte to secure additional street lighting on or adjacent to the site.


