WHEREAS, the City Council has approved the preliminary assessment roll for said improvements; has deposited same in the City Clerk's office for public inspection; has caused notice of hearing thereon to be published; and has held a public hearing thereon, all pursuant to the City Charter and the General Statutes of North Carolina,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

That the preliminary assessment roll for improvements completed on Chesterfield Avenue, from Bascom Street to Hanover Street, heretofore approved by Resolution adopted the 8th day of January, 1968, and is hereby confirmed at 3:07 o'clock p.m., this 29th day of January, 1968, and is hereby made the final assessment roll for said improvements.

2. That the City Clerk is hereby directed to enter on the minutes of the City Council and the assessment roll, the date, hour and minute of the confirmation thereof and to deliver a copy of said assessment roll to the City Tax Collector for collection pursuant to law.

3. That, after the expiration of twenty (20) days from this date, the City Tax Collector shall cause to be published one time in some newspaper published in the City, a notice that any assessments contained in said assessment roll may be paid in full to the City Tax Collector without interest thereon at any time before the expiration of thirty (30) days from the date of such publication, or, at the option of the property owners, to be exercised by giving written notice to the City Tax Collector within said thirty (30) days, may be paid in not less than two (2) or more than ten (10) equal annual installments, with interest thereon at six percent (6%) per annum, the first installment with interest to become due and payable on the date on which taxes are due and payable, and one subsequent installment with interest shall be due and payable in each successive year on the date on which taxes are due and payable until the assessment is paid in full.

A RESOLUTION AUTHORIZING MAYOR STAN R. BROOKSHIRE TO EXECUTE MODEL NEIGHBORHOOD PLANNING GRANT CONTRACT.

WHEREAS, the Demonstration Cities & Metropolitan Development Act of 1966 authorizes grants by the United States Department of Housing & Urban Development to cities to pay eighty percent (80%) of the cost of planning and developing comprehensive city demonstration programs; and

WHEREAS, the City of Charlotte Model Neighborhood proposal and application for grant assistance submitted to the United States Department of Housing & Urban Development in April, 1967, has been approved by that department, contingent upon the completion of certain revisions and improvements; and

WHEREAS, the Charlotte Model Neighborhood Commission has been duly constituted by the Mayor and City Council for the purpose of planning and developing a comprehensive city demonstration program for Charlotte; and

WHEREAS, the requested revisions and improvements will be submitted to the United States Department of Housing & Urban Development in the revised Charlotte Model Neighborhood proposal prepared by the Charlotte Model Neighborhood Commission;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte that Mayor Stan R. Brookshire be and hereby is authorized to execute, on behalf of the City of Charlotte and the Charlotte Model Neighborhood Commission, a Model Neighborhood Planning Grant Contract with the United States Department of Housing & Urban Development.
