RESOLUTION FIXING DATE OF PUBLIC HEARING ON  
THE PETITION REQUESTING THE ANNEXATION OF  
PROPERTY TO THE CITY OF CHARLOTTE, PURSUANT  
TO G. S. 160-452, AS AMENDED.

WHEREAS, a Petition requesting the annexation of the area described herein has been received; and

WHEREAS, certification by the City Clerk as to the sufficiency of said Petition has been made.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That a public hearing on the question of annexation of the area described herein will be held in the Council Chamber in the City Hall, Charlotte, North Carolina, at 3 o'clock, P. M. on the 24th day of January, 1966.

Section 2. The area proposed for annexation is described as follows:

Crab Orchard Township, Mecklenburg County, North Carolina. BEGINNING at the intersection of the present City Limits line of the City of Charlotte and the northerly boundary of Milton Road; thence with the present City Limits line N 6-16-35 W 2123.72 feet to a point in the center of a branch, said branch being the common boundary of the School Board Property as per Deed Book 2391 at page 285 of the Mecklenburg County, North Carolina, Public Registry, and the property of Ed Griffin Development Corp.; thence running with the center line of said branch six courses and distances as follows: (1) N 68-10-50 E 49.11 feet, (2) N 38-09-30 E 106.83 feet, (3) S 58-37-20 E 89.10 feet, (4) S 87-34-20 E 25.08 feet, (5) S 66-09-50 E 137.09 feet and (6) S 44-11-20 E 8.0 feet; thence leaving said center line of said branch and running with the division of said School Board Property and the property of Ed Griffin Development Corp. N 43-06 E 59.64 feet to a point in said division line; thence N 16-41 E 263.63 feet to a point in said division line, said point being in the center line of the American Telephone and Telegraph Company cable right-of-way as per Deed Book 717 at page 598 of said Registry; thence continuing with said division line and also the center line of said American Telephone and Telegraph Company cable right-of-way N 80-11 E 158.0 feet to a point on the westerly boundary of Barrington Road; thence running with the westerly margin of Barrington Road, said line also being the division line of said School Board Property and the property of Ed Griffin Development Corp., four courses and distances as follows: (1) with the arc of a circular curve to the left having a radius of 475.66 feet, a distance of 145.51 feet to a point; thence (2) N 10-01 W 173.0 feet to a

point; thence (3) with the arc of a circular curve to the left having a radius of 4975.76 feet, a distance of 198.78 feet to a point; thence (4) N 12-18-20 W 261.68 feet to a point, said point being the common corner of said School Board Property, John Crosland Company property as per Deed Book 2008 at page 39 of said Registry, and Ed Griffin Development Corp.; thence crossing Barrington Road and running S 57-36-30 E 474.86 feet to a point; thence S 56-32-30 E 329.83 feet to a point; thence S 29-35-40 W 920.45 feet to a point; thence S 47-36-30 E 260.15 feet to a point on the westerly edge of the cul de sac of Markway Drive; thence running with the arc of a circular curve to the left having a radius of 60 feet, the curve of the cul de sac, 252.83 feet to a point on the southerly edge of said cul de sac; thence running with the southerly margin of Markway Drive, N 77-26 E 107.11 feet to a point on the southerly margin of Markway Drive; thence leaving said southerly margin of said Markway Drive and running S 13-12-15 E 456.91 feet to a point; thence running N 88-02-20 E 819.80 feet to an old iron, said old iron marking the common corner, now or formerly, of the Juanita Price Leazer property as per Deed Book 638 at page 10 of said Registry and Block A of King Acres as shown in Map Book 7 at page 189 of said Registry, thence running with the Juanita Price Leazer property, now or formerly, S 5-14-W 242.44 feet to another old iron; thence continuing with said Juanita Price Leazer property, now or formerly, S 80-14-20 E 484.65 feet to an old iron, the common corner of the property of Homer W. Baucom, now or formerly, as per Deed Book 1262 at page 314 of said Registry, thence running S 1-30-40 W 425.60 feet to another old iron, the common corner of the W. L. Cuthbertson property, now or formerly, as per Deed Book 617 at page 477 of said Registry and R. C. Austin property, now or formerly, as per Deed Book 1464 at page 103 of said Registry; thence with said R. C. Austin property, now or formerly, S 13-32-30 W 206.07 feet to another old iron on said R. C. Austin property, now or formerly, thence running N 80-34-15 W 87.14 feet to another old iron; thence S 35-22-10 W 254.23 feet to a point; thence N 80-59 W 761.39 feet to a point, the common corner of the Duke Power Company property, now or formerly, as per Deed Book 1817 at page 427 of said Registry; thence running with the said Duke Power Company property, now or formerly, S 9-01 W 470.40 feet to a point on the northerly boundary of Milton Road; thence running with the northerly line of said Milton Road N 80-59 W 1120.66 feet to the point or place of BEGINNING, and containing 88.7 acres as shown on survey of H. E. McCauley, N.C.R.L.S., dated November 26, 1965.

Section 3. Legal notice of said public hearing shall be published in The Charlotte News, a newspaper having general circulation in the City of Charlotte, at least ten (10) days prior to the date of said public hearing.

RESOLUTION ENDORSING AND URGING SUPPORT FOR THE \$9,275,000 BOND ISSUE TO BE SUBMITTED TO THE VOTERS BY THE BOARD OF COUNTY COMMISSIONERS OF MECKLENBURG COUNTY IN AN ELECTION ON JANUARY 25, 1966.

WHEREAS, the Board of County Commissioners has determined that the interest of all residents of Mecklenburg County will be served through the approval of bonds in the amount of \$9,275,000 in a special election on January 25, 1966; and

WHEREAS, the bonds will provide funds for expansion of Central Piedmont Community College, an education center, expansion of emergency and out-patient clinic facilities at Charlotte Memorial Hospital, a new mental health clinic, a new jail, and renovating and remodeling the county courthouse to provide additional courtroom space; and

WHEREAS, these new and improved facilities, necessitated by the fast growth and progress of the Charlotte-Mecklenburg Community, are needed to improve the governmental services each citizen of Mecklenburg County receives - including the people of the City of Charlotte equally with the people living outside the city.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Charlotte that the proposed bond issue is hereby endorsed; and

BE IT FURTHER RESOLVED that all voters of the City of Charlotte, and Mecklenburg County as a whole, are hereby urged to support, and vote for the bonds which will provide the new and improved facilities needed to keep pace with the growth and progress of the Charlotte-Mecklenburg community.
