

A RESOLUTION PROVIDING FOR A PUBLIC HEARING JULY 17 1961
ON A PROPOSED AMENDMENT TO THE ZONING ORDINANCE.
(Area bounded by Providence Road, a line near Sharon Lane, Arborway, and McMullen Creek)

WHEREAS, at the meeting of the City Council on June 19
1961, the following amendment to the City Code was introduced:

"Ordinance No. 36-Z. An Ordinance Amending Chapter 23
of the City Code - Zoning Ordinance

An Ordinance Amending the City Code
with Respect to the Zoning Ordinance

"BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

Section 1. That Chapter 23, Article II, Section 23-43 of the City Code of the City of Charlotte, be amended by having Building Zone Map of the Charlotte Perimeter Area amended by changing from Rural to Residence 1 the following described property:

BEGINNING at the intersection of the southwesterly margin of Providence Road and the centerline of McMullen Creek and running thence in a northwesterly direction with said margin of Providence Road 4,500 feet, more or less, to an existing Residence 1 zoning district boundary line located 400 feet southeast of Sharon Lane; thence with said zoning district boundary line four courses as follows: (1) with a line parallel to and 400 feet southeast of the southeasterly margin of Sharon Lane 1,650 feet, more or less, to a line parallel to and 200 feet northeast of the northeasterly margin of Pelham Lane; (2) with said line parallel to Pelham Lane 870 feet, more or less, to a line parallel to and 200 feet northeast of the northeasterly margin of Abingdon Road; (3) with said line parallel to Abingdon Road 1,600 feet, more or less, in a southeasterly direction to a corner of the existing Residence 1 district; (4) in a southwesterly direction 750 feet, more or less, to the northeasterly margin of Arborway; thence in a southeasterly direction with said margin of Arborway 2,050 feet, more or less, to the centerline of McMullen Creek; thence in a northeasterly direction with said centerline 4,350 feet, more or less, to the BEGINNING and being that portion of the area bounded by Providence Road, Sharon Lane, Pelham Lane, Abingdon Road, Usher Lane, Arborway, and McMullen Creek not now zoned Residence 1.

Section 2. That this ordinance shall become effective upon its adoption after a public hearing in connection therewith."

AND, WHEREAS, under the law no amendment to the Zoning Ordinance can be adopted until a public hearing thereon is held, of which public hearing notice is required to be given publication not less than fifteen days immediately preceding the date of such hearing;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHARLOTTE:

1. That July 17, 1961, at 2 o'clock p.m., be fixed as the time and the Council Chamber in the City Hall as the place for the public hearing on the proposed amendment as above set out.
