RESOLUTION FIXING DATE OF PUBLIC HEARING
ON PETITION TO CLOSE PORTIONS OF CRISMAN
STREET AND PACIFIC STREET.

WHEREAS, the Charlotte Coca Cola Bottling Company and Freedom Drive Investment Co. have petitioned the City of Charlotte to close portions of Crisman Street and Pacific Street under procedure for closing streets as outlined in the North Carolina General Statutes, Section 160-200 (11) and Section 153-9 (17), and;

WHEREAS, said procedure requires that a public hearing be held after notice to the abutting land owners not joining in the petition and after publication in a newspaper once a week for four consecutive weeks.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte that a public hearing on the question of closing that portion of Crisman Street extending from Freedom Drive to Pacific Street and that portion of Pacific Street extending from Crisman Street, southwesterly to the property of the Alexander Estate (now or formerly) shall be held at 3 p.m. on Monday, the 5th day of April, 1965, in the Council Chamber of the City Hall. The City Clerk is hereby directed to publish such a notice in The Charlotte News, a newspaper published in the City of Charlotte, once a week for four successive weeks next preceding the date fixed here for such hearing, as required by G. S. 153-9 (17).
