

RESOLUTION APPROVING PRELIMINARY ASSESSMENT ROLL FOR IMPROVEMENTS
COMPLETED ON OLINDA STREET FROM KILDARE DRIVE TO ILFORD STREET AND
PROVIDING FOR NOTICE AND PUBLIC HEARING ON CONFIRMATION THEREOF.

WHEREAS, pursuant to petitions of the majority of owners owning a majority of the lineal feet of frontage of abutting property, Olinda Street, from Kildare Drive to Ilford Street, has been improved by the construction of open ditch storm drainage and paving with base course and surface course under petition filed October 22, 1962, and further improved by construction of roll type curb and gutter and installation of additional storm drainage facilities under petition filed February 12, 1964, and

WHEREAS, the City Council has ascertained the total cost of said completed improvements and has caused to be prepared a preliminary assessment roll therefor,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That the total cost of the aforesaid improvements to be assessed is \$7,814.40.
2. That the preliminary assessment roll for said improvements, showing the names of persons assessed, the amount assessed against them, respectively, and the lots or parcels of land assessed, is hereby deposited in the office of the City Clerk for inspection by parties interested.
3. That the City Council will meet at 3:00 o'clock p.m., on the 25th day of October, 1965, in the Council Chamber in the City Hall for the hearing of allegations and objections in respect to said preliminary assessment prior to confirmation or correction thereof at said meeting.
4. That notice of completion of said preliminary assessment roll, setting forth in general terms a description of said improvements and the time fixed for the meeting of the City Council for the hearing of allegations and objections in respect to said assessment, shall be published at least ten days prior to said meeting, as provided by law.

WHEREAS, pursuant to petition of owners of abutting property, the City Council on the 4th day of November, 1963, adopted a resolution ordering that Olinda Street, from Kildare Drive to end at cul-de-sac, be permanently improved by installation of storm drainage facilities, construction of roll type curb and gutter, and paving with base course and surface course, and

WHEREAS, said improvements have been completed and the City Council has ascertained the total cost thereof and has caused to be prepared a preliminary assessment roll therefore,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

RESOLUTION APPROVING PRELIMINARY ASSESSMENT ROLL FOR IMPROVEMENTS COMPLETED ON KILDARE DRIVE FROM OLINDA STREET TO JOYCE DRIVE AND PROVIDING FOR NOTICE AND PUBLIC HEARING ON CONFIRMATION THEREOF.

WHEREAS, pursuant to the provisions of the City Charter, the City Council was petitioned by one of the two owners of abutting property to make certain improvements on Kildare Drive and assess the total amount to be assessed for said improvements against the property of the petitioner, and

WHEREAS, pursuant to said petition, the City Council, on the 4th day of November, 1963, adopted a resolution ordering that Kildare Drive, from Olinda Street to Joyce Drive, be permanently improved by installation of storm drainage facilities and paving with base course and surface course and that a portion of said street be further improved by construction of roll-type curb and gutter along the frontage owned by petitioner only, and

WHEREAS, said improvements have been completed and the City Council has ascertained the total cost thereof and has caused to be prepared a preliminary assessment roll therefor,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Charlotte, North Carolina:

1. That the total cost of the aforesaid improvements to be assessed against the petitioner is \$3,305.56.
2. That the preliminary assessment roll for said improvements, showing the name of the petitioner, the amount assessed against him, and the lots or parcels of land assessed, is hereby deposited in the office of the City Clerk for inspection by parties interested.
3. That the City Council will meet at 3:00 o'clock p.m., on the 25th day of October, 1965, in the Council Chamber in the City Hall for the hearing of allegations and objections in respect to said preliminary assessment prior to confirmation or correction thereof at said meeting.
