Odds of winning depend upon the number of eligible entries received. Contest entries are limited to one entry per person per survey. LYNX Silver Line Survey Gift Card Giveaway (the "Contest") begins at 6:00:00 AM Eastern Standard Time on November 1, 2022 and ends at 5:00:00 PM Eastern Standard Time on November 17, 2022. Each completed survey counts as one entry into giveaway. The contest administrator's computer is the official time-keeping device for the sweepstakes.

Eligibility:

The Contest is open only to legal residents living in Gaston, Mecklenburg and Union Counties of North Carolina who are at least 18 years of age when they submit their entry. Employees of the City of Charlotte (the "Sponsor") and their immediate families (and those living in their same households) are not eligible to participate in the Contest. How to Enter:

Each Participant must provide a valid email address in the survey to be considered for the giveaway. Multiple survey submissions from the same email address after the initial submission will be considered invalid.
