### **NOTICE TO BIDDERS**

As a precautionary measure due to COVID-19, City will not conduct in-person Pre-Bid and Bid Opening Meetings. Until further notice, all Pre-Bid conferences, and Bid Openings will be accessible **via conference call or video conference only**.

### **DESCRIPTION OF WORK:**

The project proposes to add sidewalks and bike lanes by widening parts of J.W. Clay Boulevard. Sidewalks are currently in place in some stretches of this street; however, they will be upgraded to wider 8-foot sidewalks. The roadway and median width will be adjusted to allow for the addition of bike lanes. The conceptual cross-section includes four travel lanes with four left-turn lanes at intersections, a 12-foot cycle track, a 10-foot multiuse path,

curb & gutter, 8-foot sidewalk & planting strip and street trees. The project will include connectivity to the Barton Creek Greenway interface with J.W. Clay Boulevard.

The project also includes the intersection of W.T. Harris Boulevard, J.W. Clay Boulevard and McCullough Drive and will provide a safe pedestrian and bicycle crossing at the intersection. The project will, among other things, tie the J.W. Clay Boulevard Streetscape project in to the McCullough Drive Streetscape project.

Bidding documents, which includes a downloadable copy of one (1) Project Manual and one (1) full-size Drawing set, are available for free from the Procurement Portal.

Bidders must be properly licensed under North Carolina state law to perform the work.

A **5%** bid security is required with each bid that equals or exceeds **\$300,000**.  
The estimated cost range of this Project is **\$5M -10M**.
