

# Transform commutes with the new rapid transit hub, bringing convenience and connectivity.



The proposed Hambright Park and Ride will be a mobility hub to provide rapid transit services to the Town of Huntersville, NC and surrounding areas by utilizing the newly constructed express lane direct connect. The proposed project will construct a transit park and ride with approximately 500 parking spaces, a new public street to access the site, driver comfort station, internal pedestrian circulation, provisions for a mobility hub for micro-mobility options and/or shared ride services and site security and surveillance. It will also include landscaping, bicycle and pedestrian amenities and an Art-in-Transit component.

This project will contribute to the Metropolitan Transit Commission North Corridor public transportation strategy. The proposed location is within the limits of the Town of Huntersville, Mecklenburg County, North Carolina along the south side of Hambright Road (NC 2117), situated between Mt. Holly-Huntersville Road (NC 2004) and Interstate 77. The proposed lot will be similar in size and scale to other CATS Park and Ride lots.

Offer a range of amenities, including a driver comfort station, internal pedestrian circulation and bicycle and pedestrian facilities




Art-in-Transit component will enhance the visual appeal of the facility, creating a welcoming environment for commuters and contributing to the community's aesthetic value

Design: January 2024 - April 2025

Advertise, Bid and Award: April 2025 – July 2025 Construction: July 2025 – December 2026



- In February 2020, the MetroRAPID Bus Rapid Transit (BRT) service began along the I-77 corridor, utilizing the I-77 Managed Lanes.
- In May 2022, the Metropolitan Transit Commission (MTC) adopted a MetroRAPID Improvements Planning Study.
- The study analyzed the implementation of improvements to the service, including all-day service (nights and weekends), additional park and ride facilities, direct connections into the managed lanes, and integrating BRT stations into mixed-use developments.
- The Hambright Park and Ride was identified as the first of four new Park and Ride facilities to provide BRT service on the I-77 Corridor.
