The regular meeting of the City Council was held in the Council Chamber of the City Hall, on Wednesday, August 18, 1937 at 11:00 o'clock A. M., with Mayor Douglas presiding and Councilman Albea, Baxter, Durham, Hovis, Huntley, Nance, Sides and Wilkinson present.

Absent: Councilmen Hudson, Griswold and Little.

On Motion of Councilman Albea, seconded by Councilman Huntley and carried, the reading of the Minutes of the last two Meetings was dispensed with.

REQUEST FOR SEWER EXTENSION ON WEST SECOND STREET, FROM WALNUT AVE. TO GRANDIN ROAD APPROVED.

The City Manager presented a request from Mr. I. J. Lowman, Jr. for the extension of a sewer on West Second Street, from Walnut Ave., 174-feet, east towards Grandin Road. On Motion of Councilman Wilkinson, seconded by Councilman Baxter, and carried, this extension was approved.

DELINQUENT STREET ASSESSMENTS VOTED NOT TO BE ADVERTISED THIS YEAR.

On motion of Councilman Baxter, seconded by Councilman Huntley, and carried, it was decided upon the recommendation of Tax Collector Armstrong, City Attorney Boyd and City Manager Marshall, that the delinquent street assessments not be advertised this year.

SUIT OF METROPOLITAN LIFE INSURANCE COMPANY AGAINST CITY REPORTED.

The City Manager reported notice had been received of suit against the City of the Metropolitan Life Insurance Company for Street Assessments on West Fifth Street in the amount of \$668.36, and on Kenilworth Avenue for \$1,227.98, both of which have been referred to the City Attorney for handling.

SUIT OF JUNE BECKHAM REPORTED.

The City Manager reported notice of suit of June Beckham against E. R. McCoy, trading as the Dime Taxi Company, in the amount of \$5,000.00. Mr. Marshall explained that the City was involved in this only in that Bond was posted with the City by this Taxicab Company in lieu of insurance, and the plaintiff was notifying the City to reserve sufficient of these funds to cover this suit.

REQUEST FOR REDUCTION IN MINIMUM WATER SERVICE CHARGE
REFUSED DAYTON RUBBER COMPANY.

The City Manager read a letter from Mr. H. A. Rose, of the Dayton Rubber Company, of Charlotte, requesting a reduction in the minimum water service charge for their plant, explaining that the plant was not in operation and the water only being used for drinking purposes at the present, and the minimum charge of \$10.00 appeared to be excessive to them. After discussion Councilman Baxter made a motion that the request be denied unless they wanted to pay for and install a 3/4 inch meter, the motion was seconded by Councilman Huntley and carried.

PURCHASE OF ONE \$5,000.00 CLEVELAND COUNTY BOND.

On motion of Councilman Sides, seconded by Councilman Albea, and carried, the City Treasurer was authorized to purchase one \$5,000.00 Cleveland County, Township #6, Public Road 5% Bond, due January 1, 1939, to yield 1.75 for the Sinking Fund Account, subject to the approval of the Local Government Commission.

FOOT BRIDGE AT EAST 15TH STREET REQUEST DEFERRED UNTIL NEXT MEETING.

Mr. Wilkinson, Chairman of the Public Works Committee, requested that the matter of the construction of the foot-bridge over Sugaw Creek at E. 15th Street, which was brought up at the last meeting, be deferred until the next meeting, as his Committee had not been able to get together to investigate the advisability of the construction.

TEST CASE ON BOND ISSUES.

In an effort to determine the city's ability to issue bonds under the Debt Limitation Amendment and on the advice of Masslich & Mitchell as reported in a letter the City Attorney Boyd and Councilman Wilkinson moved that steps be taken at once to bring a test case before the Supreme Court so that the Court's decision may be obtained. The motion was seconded by Councilman Albea and carried.

CITY ATTORNEY AUTHORIZED TO EMPLOY ADDITIONAL HELP TO
ASSIST IN HANDLING DAMAGE SUITS.

Mayor Douglas, read a letter from City Attorney Boyd which he stated that it would be necessary to have the assistance of additional Attorneys in handling the damage suits against the city now pending.

Councilman Wilkinson moved that Mr. Boyd be authorized to employ the necessary assistants. The motion was seconded by Councilman Hovis and carried.

TEST CASE FOR AIRPORT MAINTENANCE.

On motion of Councilman Hovis, seconded by Councilman Albea, and carried, the City Attorney was instructed to prepare a test case in regard to the maintenance of the Municipal Airport, as the City has previously appropriated \$25.00 for this purpose.

APPROVAL OF SCHOOL SUPPLEMENTAL BUDGET FOR 1937-38.

Councilman Durham, Chairman of the Finance Committee gave a report of the Committee's findings in regard to the School's Supplemental Budget for 1937-38. With the aid of an investigation of the school records by H. C. Northrop, Certified Public Accountants, the Committee found there to be an available surplus of \$28,552.64 instead of \$9,593.39 as shown in the report of the School Board. This was explained in that a different method was used in calculating the expected revenue from prior year taxes. A motion was made by Councilman Albea, seconded by Councilman Wilkinson that 10% of this surplus be recommended for salary increases for Class Room Teachers. During the discussion Councilman Sides suggested that the recommendation be made to include salary increases for Special Teachers as well as Class Room Teachers. Also during the discussion Councilman Baxter, stated as information, that it had also been found that funds amounting to \$14,000.00 were available and due the School Board by the City, but had not as yet been called for. Councilman Durham, stated that the School Board estimated that a 10% increase in salaries for Class Room Teachers would aggregate \$15,585.01 against the available surplus of \$9,593.39 as shown in the School's Report, but since the surplus was found by the Committee to be \$28,552.64 it was the opinion of the Committee that there was a sufficient surplus to grant this increase. Councilman Albea, withdrew his motion and made a new motion that the Council approve the School Supplemental Budget for 1937-38 with the recommendation that a 10% increase in salaries be made to both the Class Room Teachers and the Special Teachers. This motion was seconded by Councilman Wilkinson and carried.

HALF HOLIDAY FOR CITY EMPLOYEES TO ATTEND AMERICAN LEGION JUNIOR BASEBALL GAME ON AUGUST 20TH DATE CHARLOTTE TEAM PLAYS.

On motion of Councilman Wilkinson, seconded by Councilman Durham and carried, the City Employees were given a half holiday to attend the American Legion Junior Baseball Game, on Friday August 20th. Councilman Wilkinson explaining that he felt the importance of having these games played in Charlotte justified this holiday.

ADJOURNMENT.

On motion of Councilman Albea, seconded by Councilman Huntley and carried, the meeting adjourned.

and that the Mayor and Clerk sign the contract for the amount of \$8,600.78. Motion unanimously carried.

AGREEMENT WITH SOUTHERN RAILWAY COMPANY.

On motion of Councilman Wilkinson, seconded by Councilman Albea and unanimously carried, the Mayor and Clerk were authorized to execute an agreement, on the part of the City of Charlotte, with the Southern Railway Company covering the construction of a water line under their tracks on Fordson Street and Norris Avenue, this being the regular agreement form used for this purpose.

PIEDMONT AND NORTHERN RAILWAY REQUEST TO CROSS CERTAIN CITY STREETS GRANTED.

The Piedmont and Northern Railway Company, who are opening up an industrial development in the area between Tuckaseegee Road and the new Thrift Road, within the City limits, requested permission to cross State Street, Tuckaseegee Road and Thrift Road with these tracks. The City Manager reported that he had taken the matter up with the State Highway Commission who built and maintain the Thrift Road and they have granted their permission for this crossing. Mr. Marshall, therefore, recommended that the City also grant this Company permission to cross these streets. Councilman Wilkinson moved that this request be granted, which motion was seconded by Councilman Hovis and unanimously carried.

STATE HIGHWAY ALLOTMENT FOR MAINTENANCE HIGHWAYS WITHIN THE CITY.

Mr. Marshall reported receipt of a letter from Mr. L. B. Peck, Division Engineer, State Highway Commission, advising that the City's allotment for maintenance of highways within the City this fiscal year is \$25,000.00.

WATER LINE IN MARGUERITE STREET TAKEN OVER BY CITY.

The City Manager advised that he had received a claim from Mr. S. W. Dandridge in which he states that the City agreed to take over a certain water line constructed by his Company when this water line was productive to the City. The cost of the line was \$61.25 and the Superintendent of Water Works reported that the income from this line is enough to warrant the City purchasing it. Mr. Marshall recommended that it be taken over, and on motion of Councilman Sides, seconded by Councilman Hudson and unanimously carried, this request was granted.

PLUMBING WORK AT THE STADIUM.

In the construction of the Stadium it was necessary to secure the services of a plumber and this skilled labor was secured from the C. R. Willmann Plumbing & Heating Co. on an hourly basis of \$1.75, including small tools, etc. The total amount of this labor was \$463.75, which was done by the City for the account of the Park and Recreation Commission. Councilman Albea, seconded by Councilman Wilkinson, moved that the Mayor and Clerk execute a contract with the C. R. Willmann Plumbing & Heating Company in this amount, which motion was carried.

FOOT BRIDGE ACROSS SUGAW CREEK AT EAST 15TH STREET.

In the matter of foot bridge across Sugaw Creek at East 15th Street and McDowell, which was referred to the Public Works Committee for report at a recent meeting, Councilman Wilkinson, Chairman of this committee, reported that this had been investigated and that his committee found that it would be necessary to obtain the right-of-way over a small strip of private property in order to do so, and recommended that if this right of way could be obtained that this bridge be built. The work is estimated to cost \$488.00 and Councilman Wilkinson, seconded by Councilman Albea, made a motion that when the matter of right of way is cleared up that the bridge be built. Motion unanimously carried.

AUTEN STREET TAKEN OVER FOR CITY MAINTENANCE,

On motion of Councilman Albea, seconded by Councilman Hudson, Auten Street, from Sumter Avenue to West 4th. Street, was taken over for maintenance; the cost of this work being estimated at \$372.63.

APPOINTMENTS.

Mr. Marshall reported the employment of Mr. J. F. Haley as Radio Dispatcher in the Police Department, and Mr. M. A. Brown as Assistant Clerk in the Filing Bureau.

COPY OF 1927-1938 BUDGET FURNISHED EACH COUNCILMAN.

A copy of the 1937-1938 Budget was furnished each member of the Council at this time.

KENSINGTON AVENUE TAKEN OVER FOR MAINTENANCE.

On motion of Councilman Baxter, seconded by Councilman Albea, that part of Kensington Avenue between Kenwood Ave. and Fulton Street, was taken over for City maintenance, on agreement of the property owners that they would donate a strip of land to make this a 30-ft. street.

PROPERTY ON STATESVILLE ROAD TO BE ADVERTISED FOR SALE.

Councilman Huntley, Chairman of the Real Estate Committee reported that he had received another offer from Mr. Clay Rutledge for the property on Statesville Road on which he had made a previous offer, and that Mr. Rutledge was now offering \$125 per acre, which Councilman Huntley stated he felt was a good price for this land.

He thereupon moved that the City advertise this property at this price, which motion was seconded by Councilman Albea and carried.

REFUND TO PARK AND RECREATION COMMISSION INTEREST CHARGED ON MONEY ADVANCED.

Councilman Sides stated that the City of Charlotte had advanced to the Park & Recreation Commission at two different times sums of money, on which it had charged 6% interest, amounting to \$438.59 for the two advances, which he felt was an injustice inasmuch as the City received 8% on unpaid taxes, and he moved that the City refund to the Park & Recreation Commission the amount of interest already received on these advances, and to refrain from charging them on money furnished them in anticipation of collection of back taxes, if the City does not have to borrow the money in order to make the loans. This motion seconded by Councilman Durham and unanimously carried.

PROPOSED AMENDMENT TO SUNDAY ORDINANCE.

Councilman Baxter stated that he felt that the City of Charlotte should do something to keep the baseball franchise owners in Charlotte and moved that the present Sunday ordinance be amended by striking out in Section 1 thereof the following paragraph:

"or to engage in or operate any place of amusement, show, game, or sport where a fee is charged for admission as a spectator, or to participate in any game or sport or amusement where an admission fee is charged, whether such admission fee shall be upon a club basis or otherwise."

This motion was seconded by Councilman Hovis

Councilman Wilkinson, seconded by Councilman Huntley then offered a substitute motion to hold this over until next Wednesday because of the absence of two members of the Council.

The following vote is recorded on the substitute motion:

After discussion, Mayor Douglas ruled the motion lost and a vote was then called for on the original motion, which was as follows:

The Mayor also declared this motion lost.

TRAFFIC SITUATION ON TRYON STREET AT FOURTH AND FIFTH STREETS.

Councilman Wilkinson moved that the restrictions regarding "no-turn" at 4th. and 5th. Streets on North and South Tryon Street, be withdrawn and traffic be allowed to make a right hand turn, traffic in the center not to be allowed to turn. No second.

Councilman Baxter then moved that traffic be allowed to turn on the red light. No second.

Mayor Douglas suggested that the Police Committee consult
