Thompson on the unit prices stated in the proposal and that the amount of work done be limited to the amount available in the appropriation, which is approximately \$50,000.00.

DISCOUNT FOR UNCOLLECTED TAXES DISALLOWED.

In regard to the discount for uncollected back taxes, the City Manager presented for consideration the Tabulation of the total amount of taxes which would be affected by the adoption of the discount rates contained in House Bill No. 1182.

This Tab Sheet showed total uncollected taxes for the years 1920 through 1927 of \$55,191.46, with interest of \$44,724.49, making a total of \$99,915.95. The proposed discounts would amount to \$19,983.18, with net receipts of \$79,932.77.

For the years 1928 through 1934, with discount of 10%, the total amount of uncollected taxes is \$386,530.77; interest due \$120,084.90, making a total of \$509,415.67. Proposed discounts would amount to \$50,941.57, leaving net receipts of \$458,474.10.

After a thorough discussion of these proposed discounts, Councilman Durham moved that the discounts not be allowed. Motion seconded by Councilman Sides and unanimously carried.

ADJOURNWENT.

After Mayor Douglas expressed regret at the loss of two members of the present City Council for the ensuing two years, and a brief farewell from Mr. John F. Boyd, Councilman Wilkinson moved that the meeting adjourn until 10 o'clock A. M. Motion seconded by Councilman Boyd and carried.
