• Our dedication to equitable procurement practices has resulted in significant increases in spend with MWSBEs. Minority Business Enterprise (MBE) spend alone surged by more than \$10 million last year, reaching

• Among MBE spend, African American vendors received the largest share, with \$31,895,598 allocated to support their businesses. Two vendors to highlight are both African American women-owned businesses, Roundtree Companies and Diamond Trucking. These businesses secured \$1.2 million and \$1.1 million in spend, respectively, showcasing the strength and resilience of African American women in our business community.

• We have also focused on expanding and enriching the pool of MWSBE vendors. In FY 2023 we proudly welcomed 80 new vendors into the CBI MWSBE Directory. The emergence of new certified MBE firms like DeannaMichel Inc. and EDT, PLLC underscores the vitality of entrepreneurship and innovation within our community.

I extend my heartfelt gratitude to the dedicated individuals and organizations who have contributed to the success of the Office of Charlotte Business Inclusion. Your unwavering support and collaboration are instrumental as we continue to chart a path toward shared prosperity and economic empowerment.

Since its inception in July 2023, the *Contractor Development Program (CDP)* under the City of Charlotte Business Inclusion (CBI) initiative has achieved significant milestones in empowering CBI-certified MWSBEs. Our focused efforts on technical assistance, development services, and bonding capacity enhancement have yielded strong results, fostering a thriving environment for MWSBE contractors.

Highlights of the CDP's impact through February 2024

These accomplishments reflect the CDP's essential role in not only supporting but actively contributing to the economic growth and inclusivity of Charlotte's business landscape.

- **Engagement and Growth:** The program proudly registered 92 participants, indicating strong interest and engagement from the MWSBE community.
- **Comprehensive Support:** A total of 1,770 technical assistance services were provided, alongside 825 contractor development services, ensuring our contractors are well-equipped to tackle the industry's challenges.
- **Financial Empowerment:** Our contractors have experienced a significant increase in their bonding capacity, obtaining or increasing a total bond line value of \$2.85 million through the CDP.
- **Bidding Opportunities:** Notably, one contractor leveraged CDP services to secure a \$250,000 bid bond, enabling them to pursue a project that would have been otherwise inaccessible. This demonstrates the CDP's critical role in unlocking new opportunities for our participants.
- **Education and Training:** The 5-week Bidding and Estimating Training Academy graduated 37 contractors, further enhancing their competitiveness and skills. Additionally, 16 training sessions covered vital topics for business success.







The Charlotte Business INClusion (CBI) Program promotes diversity, inclusion and local business opportunities within the city's contracting and procurement process for Minority, Women, and Small Business Enterprises (MWSBEs) in the Charlotte region.

REQUIREMENTS

- Qualifying person(s) must own 51% of the business enterprise
- Personal net worth not to exceed \$750,000 (Excludes business ownership, retirement accounts, and eligible equity in residential home)
- Significant business presence in the Charlotte Combined Statistical Area "CSA."
- Provide a commercially useful function to the City
- 1/4 SBA size standard
