COMMUNITY MEETING REPORT

Petitioner: Above and Beyond Students

Rezoning Petition No. 2024-13

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

A representative of the Petitioner mailed a written notice of the date, time, and location of the Community Meeting to the individuals and organizations set out on <u>EXHIBIT A</u> attached hereto by depositing such notice in the U.S. mail on March 27, 2024. A copy of the written notice is attached hereto as <u>EXHIBIT B</u>.

The Virtual Community Meeting was held on Wednesday, April 10 via Zoom.

The Community Meeting was attended by those individuals identified on the sign-in sheet attached hereto as <u>EXHIBIT C</u>. The Petitioner was represented at the Community Meeting by Don Williams, Tim Turner and Jim Gambrell.

The Petitioner's agent, Don Williams, welcomed the attendees and introduced the Petitioner's team. Jim Gambrell indicated that the Petitioner proposed to rezone an approximately .24-acre site (the "Site") located at 4836 Park Road, Charlotte, NC 28209 from the OFC zoning district to CAC-1 zoning district. Jim Gambrell explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and respond to questions and concerns from nearby residents and property owners.

Jim Gambrell provided background information about the Site and explained that the Petitioner is making the rezoning request to bring the Site back into compliance after the change in zoning district, as part of the 2023 adoption of the City of Charlotte's new Unified Development Ordinance, changed the Site's zoning from O-2 to OFC, a designation for large office/medical campus uses. The following is a summary of the presentations Mr. Gambrell provided:

- The mission of Above and Beyond Students (ABS) is to provide quality afterschool and tutoring and summer programs that empower all students to succeed in the 21st century global community.
- ABS is a 501(c)(3) organization.
- ABS owns a small building at 4836 Park Road that it uses as an executive office.
- In an effort to be good stewards of the financial support we receive to further our mission, we are planning to sell our building and find an affordable office location to lease, freeing up capital for better use.
- As we began considering a sale, it was brought to our attention that the city's adoption of a
 new Unified Development Ordinance in 2023 and associated changes in zoning districts put
 us in the challenging position of being out of compliance with the city's new designation for
 our property, OFC. That designation is for large office and medical office buildings.
- The Charlotte Future 2040 Comprehensive Plan shows this area of Park Road to be appropriate for a Community Activity Center.

- Staff from the Charlotte Planning, Design and Development Department recommended that the designation of Community Activity Center – 1 (CAC-1) would be appropriate for our property.
- Therefore, we have filed this rezoning petition to get back into compliance from a zoning perspective and to bring our property into alignment with the city's future land use plan, The Charlotte 2040 Comprehensive Plan.

There were two attendees from the community in the Virtual Community Meeting, Vickie Amon and Indy Boteju. Vickie and Indy together own the adjacent parcel, 4900 Park Road. Mr. Boteju stated that his and Ms. Amon's interest and reason for attending the meeting was more out of curiosity about how the recent change in zoning affects their property than out of concern for the Petitioner's request. The attendees had no questions about Petitioner's use. Ms. Amon asked how the zoning designation CAC-1 was selected, and Mr. Gambrell responded that Staff from the Charlotte Planning, Design and Development Department recommended CAC-1 as an appropriate zoning classification for this parcel. Mr. Boteju asked how Petitioner knew how to go about requesting a rezoning in case he decided to do the same, and Mr. Gambrell agreed to share information that staff had provided to Petitioner, including contact information for Maxx Oliver in the planning department.

Mr. Williams thanked all participants and called the meeting to a close.
