2024-049 by Shreeji Hospitality of University, LLC for a change in zoning for approximately 3.96 acres located at the northeast intersection of North Tryon Street and Hampton Church Road, south of East McCullough Drive from TOD-TR and N1-C to TOD-CC.

2024-075 by Arbo, LLC for a change in zoning for approximately 1.4 acres located along the north side of Pineville-Matthews Road and the west side of Arboretum Drive from O-15(CD) to CAC-1(CD).

2024-077 by The Drox Group, LLC for a change in zoning for approximately 15.87 acres located at along the east side of Sandy Porter Road, south of Brown Grier Road, and west of Whitehall Park Drive from N1-A ANDO to N2-A(CD) ANDO.

2024-080 by Diallo Mamdou Korka for a change in zoning for approximately 1.658 acres located along the east side of North Graham Street and the north side of Oneida Road from I-1(CD) to ML-1.
