COMMUNITY MEETING 1 REPORT

Petitioner: Jay Kamdar

Rezoning Petition No. 2019-037

This Community Meeting Report is being filed with the Office of the City Clerk and the Charlotte-Mecklenburg Planning Commission pursuant to the provisions of the City of Charlotte Zoning Ordinance.

There have been two community meetings to discuss this proposal.

Caren Wingate, a representative of the Petitioner mailed a written notice of the date, time and location of the Community Meeting to the individuals and organizations set out on Exhibit A-1, attached hereto, by depositing such notice in the U.S. mail on August 28, 2020. A copy of the written notice is attached hereto as Exhibit B-1.

Due to the Covid-19 pandemic, the first Virtual Community Meeting was held on Thursday, September 10, 2020 at 6:00 in the evening.

The Community Meeting was attended by those individuals identified on the roster attached hereto as Exhibit C-1. The Petitioner was represented by Caren Wingate of Wingate Advisory Group and Erica Kennedy of ODA Architecture.

Caren Wingate, Agent for the Petitioner, welcomed the attendees and introduced Erica Kennedy, the Petitioner's architect and explained that the Petitioner proposed to rezone approximately 3.08 acres, located at 2528 Sam Wilson Rd from R17-MF zoning to B-2 zoning. The Agent provided contextual graphics of the area to be rezoned (attached as Exhibit D-1). She explained the rezoning process in general and stated that the purpose of the meeting was to discuss the rezoning request and respond to questions and concerns from nearby residents and property owners.

Erica Kennedy, the Petitioner's Architect, presented the site plan and pointed out various commitments made by the Petitioner.

Discussion with meeting attendees was positive. The Petitioner's team promised to create conceptual renderings, to be presented at a follow up meeting. Discussion topics are detailed on the following page.

DISCUSSION

What type of property is intended for this property? Please say it is not industrial.

The Petitioner wishes to build a hotel and small retail building on the property.

What kind of hotel is proposed?

The Petitioner intends to build a Marriott or Hilton branded product in this location.

How will you screen the adjacent properties?

Adjacent properties will be screened with a 6' high fence and a tree line.

How will the hotel benefit the local neighborhood?

The new hotel will feature a restaurant, as well as meeting and event spaces to host reunions, meetings, receptions, etc. In addition, this will be a comfortable option for visiting holiday guests. We also believe this property will offer much needed area lodging for visitors to the Whitewater Center.

What will happen on the parcel separating this property and Performance Rd?

The Petitioner does not own that property, so we cannot predict how that property will develop.

Will you provide any neighborhood services retail at this location?

The +/-3,000 sf retail building on the front of the property could accommodate neighborhood services, such as a bank, dry cleaner, etc.

Is a traffic study required for this development?

According to notification provided by NCDOT on June 17, 2020, the site does not trigger a traffic study, but will require appropriate storage and tapers for property access.

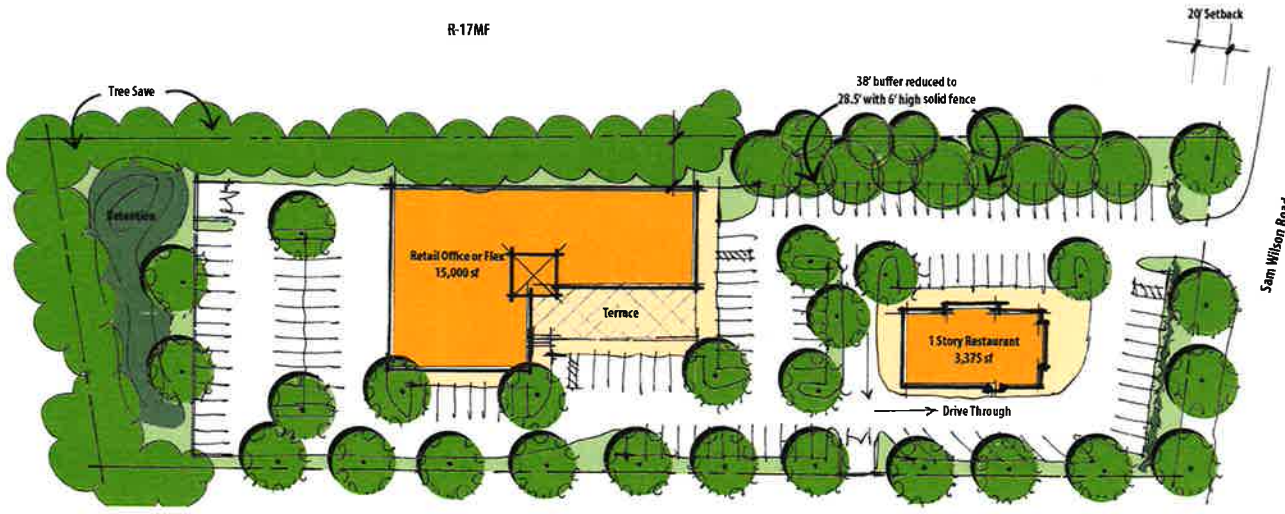

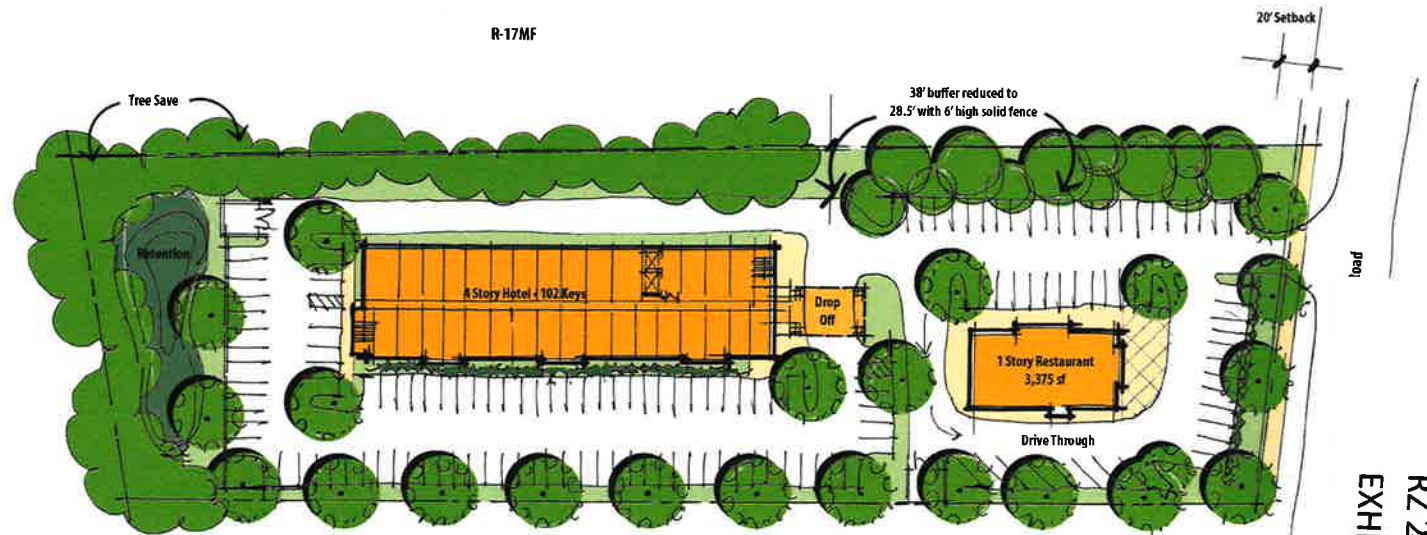
