### Summary of Request

We are assisting property owner Mark Bolous - Whitestone Holdings, Inc (the "Petitioner") with a Rezoning Petition that has been filed with the Charlotte Planning Department seeking to rezone an approximately 0.23-acre site (the "Site") located on Wallace Lane from R-5 zoning district to the MUDD(O) zoning district (Parcel ID 07101509). The proposed rezoning will be to retain an existing single-family structure and include additional parking to the rear to serve adjacent residential use. A map of the property is included in this mailing for your reference.

In accordance with the requirements of the City of Charlotte Zoning Ordinance, the Petitioner will hold a "Virtual" Community Meeting prior to the Public Hearing on this Rezoning Petition for the purpose of discussing this rezoning proposal with nearby property owners and organizations. City of Charlotte Planning, Design & Development Department's records indicate that you are either a representative of a registered neighborhood organization or an owner within 300 feet of the Petition's parcel boundaries.
